

ORDINANCE

AN ORDINANCE TO REGULATE MOTOR BOATS, WATER SKIS,
AND SURF BOARDS ON THE WAUPACA CHAIN O' LAKES.

THE TOWN BOARDS FOR THE TOWNSHIPS OF FARMINGTON AND DAYTON, WAUPACA COUNTY,
WISCONSIN, IN JOINT MEETING ASSEMBLED, DO ORDAIN AS FOLLOWS:

I.

That Ordinance, passed by the town boards for the Townships of Farmington and Dayton, Waupaca County, Wisconsin on May 31, 1949, and published on June 2, 1949, entitled "An Ordinance To Regulate Motor Boats, Water Skis, and Surf Boards on the Waupaca Chain O' Lakes" is hereby repealed in its entirety.

II.

No person shall tow water skis or surf boards while operating any motor boat on the Waupaca Chain O' Lakes in the Townships of Farmington and Dayton, Waupaca County.

III.

No motor boat shall be operated upon the Waupaca Chain O' Lakes in the Townships of Farmington and Dayton, Waupaca County, without first having obtained therefor a license as provided in Section IV of this Ordinance.

IV.

Upon the payment of the sum of \$1.00 for all motors or motor boats up to and including 5 H.P., and upon the payment of the sum of \$3.00 for all motors and motor boats exceeding 5 H.P., the town clerk shall issue or cause to be issued to the applicant, a license in the form prescribed by the town boards, which license shall run to the 31st day of December after issue. This license must be carried in the boat so operating on the Waupaca Chain O' Lakes. All such licensed inboard motor boats shall, prior to operation thereof, paint, affix or cause to be painted or affixed on both sides of the bow thereof, immediately next to the prow and deck, numbers of a color so as to be clearly visible 200 feet away with the unaided eye, and each numeral to be at least 4 inches in height and one inch in width. These numbers shall correspond to the number of the license issued.

V.

No person shall operate any boat on the Waupaca Chain O' Lakes at a speed greater than 15 miles per hour, and no vessel shall pass any point, within six rods from shore at any time of the day or night at a rate of speed of more than 6 miles per hour.

VI.

Any person who violates any provision of this Ordinance shall be punished by a fine of not less than \$10.00 nor more than \$50.00. Any person required to have a license by this Ordinance who shall be found guilty of a second violation of a provision of this Ordinance shall be punished by such fine and by revocation of his license for the current year. Any person who continues to operate his boat after the revocation of his license shall be punished by a fine of \$25.00 for each day he continues to operate his boat and, on failure to pay such fine, by imprisonment in the county jail for not more than thirty days.

VII.

Any person who shall drive, operate or use a motor boat on the Waupaca Chain O' Lakes in a careless, negligent or reckless manner so as to endanger the life, property or persons of others, shall, upon conviction be subject to a fine provided by Section VI of this Ordinance.

VIII.

If any section, part or paragraph of this Ordinance shall be declared unconstitutional or invalid, it shall not be hld to invalidate or impair the validity, force or effect of any other part, section or paragraph of this Ordinance.

IX.

This Ordinance shall take effect and be in full force upon passage and publication.
