ORDINANCE NO.

9-16-85

Establishment of a speed zone on King Road, Town of Farmington, Waupaca County, State of Wisconsin.

The Town Board, Town of Farmington, do ordain as follows:

Ordinance No. C-1326 be rescinded and replaced by the following:

Section 1. A traffic and engineering investigation having been made on the following described highway, the maximum permissible speed at which vehicles may be operated on said highway, which speed is herewith established as reasonable and safe pursuant to Section 346.57 and Section 349.11, Wisconsin Statutes, shall be set forth herein, and upon erection of standard signs giving notice thereof.

Twenty-five miles per hour for all vehicles from its intersection with State Trunk Highway 22, easterly for a distance of 0.30 of a mile.

Thirty-five miles per hour for all vehicles from a point 0.30 of a mile east of State Trunk Highway 22, easterly to its intersection with County Trunk Highway "K", a distance of 1.40 miles.

Section 2. Any person violating any provision of this ordinance may be required to forfeit not less than \$20 nor more than \$200.

C-1326 King Road, Town of Farmington, Waupaca County. *Rescinded 9-16-85

(a) Twenty-five miles per hour from its intersection with State Trunk Highway 22, easterly for a distance of 0.30 of a mile.

(b) Forty miles per hour from a point 0.30 of a mile east of State Trunk Highway 22, to its intersection with Pryse Road.

C-1327 Otter Drive, Town of Farmington, Waupaca County.

Twenty-five per hour from its intersection with State Trunk Highway 22, northwesterly to a point 0.20 of a mile south of its intersection with State Trunk Highway 54.

C-1328 Pine Ridge Lane, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its intersection with Otter Drive southwesterly to its terminus at Taylor Lake.

C-1329 Park Lane Drive, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its intersection with State Trunk Highway 22, northwesterly to its intersection with Park Lane.

C-1330 Park Lane, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its intersection with Grand Army Road, northerly to its terminus.

C-1331 Murray Lane, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its intersection with Grand View Road, westerly to its terminus.

C-1332 Grand View Road, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its intersection with County Trunk Highway "Q" northeasterly to its intersection with State Trunk Highway 22.

C-1333 County Park Lane, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its east intersection with County Trunk Highway "Q" northwesterly to its west intersection with County Trunk Highway "Q".

C-1334 Whispering Pines Lane, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its intersection with County Trunk Highway "Q", southerly and westerly to the line common to Sections 32 and 33.

C-1335 Pleasant Park Lane, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its intersection with County Trunk Highway "Q", easterly to its terminus at Round Lake.

C-1336 Snug Harbor Lane, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its intersection with Cleghorn Drive westerly to its terminus at Long Lake.

C-1337 Norris Lane, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its intersection with Smith Lane southwesterly to its terminus at McCrossen Lake.

C-1338 Lockeley Lane, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its intersection with Round Lake Road, southeasterly to its terminus at Browne Lane.

C-1339 Round Lake Road, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its intersection with County Trunk Highway "Q", northeasterly to its intersection with Smith Lane.

C-1340 Smith Lane, Town of Farmington, Waupaca County.

(a) Forty-five miles per hour from its intersection with State Trunk Highway 54, southerly to its intersection with Round Lake Road.

(b) Twenty-five miles per hour from its intersection with Round Lake Road to its terminus at Sunset Lake.

C-1341 Highland Lane, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its intersection with State Trunk Highway 54, southerly to its terminus.

C-1342 Nicks Lane, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its intersection with State Trunk Highway 54, southerly to its terminus at Sunset Lake.

C-1343 White Pine Lane, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its intersection with State Trunk Highway 54, southerly to its terminus at Sunset Lake.

C-1344 Cleghorn Drive, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its intersection with County Trunk Highway "Q" southerly to the Dayton Town Line.

C-1345 Browne Lane, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its intersection with Locksley Lane southwesterly to its terminus at Round Lake.

C-1346 Halbert Lane, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its intersection with County Trunk Highway "Q", northerly to its intersection with Grand View Road.

C-1347 Minor Drive, Town of Farmington, Waupaca County.

Twenty-five miles per hour from its intersection with County Trunk Highway "Q", southwesterly to the Dayton Town Line.
