

**Town of Farmington – Waupaca County
Ordinance No. 10/13/25(2025)**

An Ordinance Amending and Establishing Stop Sign Locations

Section 1 – Authority: The Town Board of the Town of Farmington, Waupaca County, Wisconsin, does hereby ordain as follows, under the authority granted by Wisconsin Statutes § 349.06(6), which authorizes local authorities to install and maintain official traffic control devices, including stop signs, on highways under their jurisdiction.

Section 2 - Purpose: The purpose of this ordinance is to promote public safety and regulate traffic within the Town of Farmington by establishing stop sign locations at specified intersections.

Section 3 – Applicable Rules and Penalties: The applicable stopping rules, as set forth in Wisconsin Statutes § 346.46 (and subsequent amendments), and the penalty provisions of § 346.49 (and subsequent amendments), are hereby adopted by reference and made a part of this section as if fully set forth herein.

Section 4 – Enforcement: The provisions of this ordinance shall be enforced by the Waupaca County Sheriff's Office and any other law enforcement officers authorized by Wisconsin Statutes. Violations of this ordinance shall be subject to the penalties set forth in Wisconsin Statutes § 346.49 and any applicable Town ordinances.

~~**Section 6 - Sign Installation and Maintenance:** The Town of Farmington shall cause the erection and maintenance of official stop signs at the above designated locations in accordance with the standards set forth in the Wisconsin Manual on Uniform Traffic Control Devices (MUTCD), as adopted pursuant to Wis. Stat. §§ 349.065 and 84.02(4)(e).~~

Section 7 – Severability: If any section, clause, provision, or portion of this ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this ordinance shall not be affected thereby.

Section 8 - Repealer: All prior ordinances or parts of ordinances of the Town of Farmington that conflict with or are inconsistent with the provisions of this ordinance are hereby repealed. This ordinance shall be the controlling ordinance regarding stop sign locations and related traffic control within the Town of Farmington.

Section 9 - Effective Date: This ordinance shall take effect upon passage and publication as provided by law.

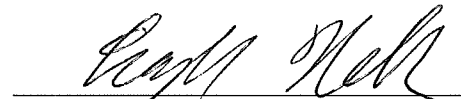
