

ORDINANCE No. 2/19/24B(2024)

An Ordinance Amending the Established Speed Limit on King Road

The Town Board of the Town of Farmington, Waupaca County, Wisconsin do ordain as follows:

Section 1: As per Wisconsin Statutes §349.11 (3)(c), authority to modify speed restrictions on any existing speed limits and shall adopt state speed limits as per Wisconsin Statutes §346.57, 346.58 and 346.59.

Section 2: No person shall drive a vehicle at a speed in excess of the following limits:

- a) Twenty-five (25) miles per hour on King Rd from State Hwy 22 to County Rd QQ.
- b) The Town Board shall cause official signs giving notice of the speed limit to be erected in such a manner and location as to give adequate warning to users of the road.

Section 3. This Ordinance shall take effect on and upon passage and publication according to law.

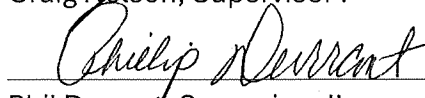

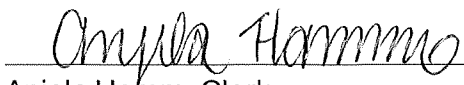
